Presentation of options and discussion of possible Transactions and Use Tax

Increase(s)

A .5% Transactions and Use tax was approved by Dunsmuir voters in 2016. The imposition is for 10 years before which it needs to be voted to continue or it will expire. It is presently scheduled to expire in 2026.

The tax was passed as a general tax and required only a 50+% vote to be successful. Prior to being placed on the ballot City Council passed Ordinance no. 545 confirming assessment if passed by voters. This required a 2/3s vote of the City Council.

It has been suggested that additional transactions and use tax be proposed to the City Council and the voters. At this time there is no TUT assessment that is countywide in Siskiyou, so up to an additional 1.5% tax could be imposed by the voters. A smaller amount could also be considered if proposed in increments of .125%.

If the tax were to be for a specific purpose, such as streets, roads and/or sidewalk improvements, a 2/3s vote of City Council and 2/3s vote of Dunsmuir voters would be required. If successful, proceeds could only be spent on streets, roads and/or sidewalks. There are many other specific needs or improvements that could also be designated such as increased police protection, parks improvements, library services, etc. Proceeds of special tax are deposited to its own fund and kept separate from general fund and other funds of City.

If a new or extended tax were to be for general purposes, only a 50+% vote of registered voters is required to be successful if ordinance establishing tax was approved by 2/3s of City Council prior to election. Proceeds would be credited to City general fund upon receipt from Board of Equalization and expensed by City Council with no restriction other than it must be for general fund eligible activities or purposes.

Presently .5% TUT is generating about \$115,000 annually for City's general fund. From this we can estimate that a 1.5% additional tax world generate about \$345,000 annually for City's general fund, if general tax, or \$345,000 for designated projects if special tax. Special tax proceeds would be kept separate from general fund accounts and revenues and expenditures accounted separately to City Council.

A draft form ordinance has been received from Board of Equalization for both general or special tax. Once the ordinance is adopted by City Council, tax proceeds would be collected starting 110 days after successful election.

The term of the tax collection can be unlimited or increments of 10 years.
