Audible Emergency Warning System
Pattern Codes



The City’s Outdoor Public Warning System is designed to alert residents and visitors of Dunsmuir about possible danger. Sirens are located throughout the city. The following explains what each type of blast means.

- Single 4 second blast – Daily at NOON (**Test**)
- 5 blasts, 4 seconds each with 4 second pauses between each blast - **Fire Department Alert**
- Continuous 1 second blasts with 1 second pauses - **Evacuation Imminent**, tune to local radio station for details*
- Continuous thirty second blasts - **Alert**, tune to local radio station for details*
- Single 2 second blasts - **Used for testing and maintenance**

*Local Radio Stations tune to: KZRO 100.1 FM / KMHC 107.9 FM/ KMJC 620 AM

Due to the dramatic increase in the cost of processing Tin Cans the Siskiyou Opportunity Center will be unable to accept them as of this notice. We also have **never** accepted newspaper in the blue bags but we still get individuals who do it anyway. As of August 13, 2015 we have stopped accepting newspaper all together because the cost to process it is now more than we can afford. **Please do not put any of the listed items below in the Bluebags.** It is costing the Opportunity Center thousands of dollars in labor to dispose of them. We need your help! We simply do not have the space or resources to do it all.

IF ANY OF THE RESTRICTED ITEMS BELOW ARE FOUND IN THE BLUE BAGS YOU WILL RECEIVE ONE NOTICE. THE SECOND INFRACTION WILL RESULT IN YOUR BAG BEING LEFT AT THE CURB.

Items that **DO NOT** go into the Bluebags.

- **NO Tin Cans**
- NO Cardboard of any kind (This includes cereal boxes, beer boxes etc.)
- NO Magazines
- NO Newspaper
- NO Plastic Bags, Grocery Bags, or Paper bags
- NO Printer paper, bond paper, junk mail, paper of any kind
- NO Phone books
- NO Popcorn Peanuts
- NO Styrofoam of any kind or size
- NO Wax Milk Cartons
- NO Oil Containers (Motor Oil)
- NO Nursery Pots or Flats
- NO Ceramic of any kind such as Plates and Dishware
- NO Drinking glasses or scrap window glass. They can contain lead.
- NO Small Appliances of any kind.
- NO Food or yard waste

Items that **CAN** go into the Bluebags.

- Aluminum cans
- Plastics bottles (soda juice beer etc.)
- Aluminum Cat food cans
- Household plastics 1-7 (See exceptions above)
- Glass – (Food jars, wine, beer, soda, juice etc.)

* Bags Must Be Tied *
